- The bids will be opened in the presence of Bidders' representatives who choose to attend at 1.00 PM on 2076-11-25 (8th March, 2020).at the Phalewas Municipality, Office of Municipal Executive, Parbat.
- 6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs 2,70,000.00, which shall be valid for 30 days beyond the validity period of the bid .
