4. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np. **On or before 12.00 noon 2076-12-04 (17th March, 2020)**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1.00 PM** on **2076-12-04 (17th March, 2020)** at the Phalewas Municipality, Office of Municipal Executive, Parbat.
6. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format, which shall be valid for **30 days** beyond the validity period of the bid.
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
